We may monitor, and record calls made to us for the purposes of quality assurance, legal, regulatory and training.

5. Protection of information

We maintain strict security measures to protect personal information. These measures include technical and procedural steps to protect your data from misuse, unauthorised access or disclosure, loss, alteration, or destruction.

We are not responsible for any links from your hosted private software database with our company or your own company website links to other recognised and respected organisations websites.
